

# 2015 TAX INFORMATION

## TAX PAYMENTS

- We will accept Check or Money Order only. Please make payable to the Town of Winchester
- You can mail your tax payment in the enclosed addressed envelope
- You can drop off your tax payment in the Drop-Off box at the town hall
- You can pay in person at the Town Hall. I will be collecting payments on:
  - December 21, 2015 8:00 am – 12:00 pm
  - December 22, 2015 1:00 pm – 5:00 pm
  - December 23, 2015 8:00 am – 12:00 pm
  - December 29, 2015 1:00 pm – 5:00 pm
  - December 30, 2015 8:00 am – 12:00 pm
  - December 31, 2015 1:00 pm – 5:00 pm
  - January 2016 – Tuesday's from 9:00 am – 12:00 pm
- If you make payment by mail or drop-off box and you would like a receipt, please include a stamped, self-addressed envelope with your payment
- If your Escrow check is more than your bill, a refund check for the difference will be mailed to you after it is authorized by the Town Board

## LOTTERY TAX CREDIT

- If you have lived in your home since January 1, 2015 you should have a Lottery Tax Credit. If you do not and you are entitled to one, please let me know when you pay your taxes. Lottery credit can be given at that time

## PAYMENT DATES

- **First Installments** are to be paid to the Town of Winchester Treasurer by January 31, 2016
- **Second Installment or Balance Due** are to be paid to the Winnebago County Treasurer by July 31, 2016. I will provide you with an addressed envelope for the Winnebago County Treasurer's office
- **Full Payments** are to be paid to the Town of Winchester Treasurer by January 31, 2016
- Envelopes postmarked by December 31, 2015 will be credited in 2015 for tax purposes

## DOG LICENSE

- Wisconsin State Statute #174.05 requires all DOGS 5 months or older to have a license
- Fees - \$10.00 per un-neutered or un-spayed dog  
\$5.00 per neutered or spayed dog
- You can find additional Dog License Application on the Town of Winchester website, townofwinchesterwi.com
- Please include an application, fee, and your pet's veterinarian's certificate for rabies vaccination for each pet
- I will mail your dog license and rabies certificate back to you
