Signs

The Town of Winchester, along with Winnebago County, and the State of Wisconsin, has sign regulation which restricts the placement of signs in the road right-of-way. The Town has been working to educate residents and businesses regarding this regulation for the past two years. The cooperation received from the majority in the community has had a positive impact on the rural landscape of our beautiful community. The Town Board would like to thank all those who have cooperated. We ask that everyone be aware of the rules and continue to help spread the word in order to keep our roadways safe from distracting signs and encroachments.

The Sign Regulation provides parameters for permanent signs through a simple permitting process during which, officials will work with the applicant to find the optimal placement for the signage.

Temporary signs (garage sales; open houses, etc.) should be kept outside of the road right-of-way which generally speaking is 33 feet from the center of a road and behind the top of the backslope of the ditch.

Snowplowing Rules to Know

Pushing snow onto or across roads from private driveways can cause accidents, death, and/or snowplow and vehicle damage and is prohibited by Wisconsin Law Statutes 86.01, 86.07, 346.94, and/or 941.03.

Snow should be managed on your own property. Please do not place snow piles in the roadside ditches. Avoid penalty and liability and cooperate towards safer roads.
