TOWN OF WINCHESTER Ordinance 2022-01

An Ordinance Regulating Vehicular Noise on Roads Within the Town of Winchester, Winnebago County, Wisconsin

The Town Board of Supervisors of the Town of Winchester, Winnebago County, Wisconsin, does hereby ordain as follows:

Section 1. Regulations relating to vehicular noise on Town roads within the Town of Winchester. Section 1 is created as follows:

- Loud and Unnecessary Noise. No person shall operate a motor vehicle on any Town
 road in a manner that causes any loud, disturbing or unnecessary sounds or noises such as
 may tend to annoy or disturb another in or about any Town road, alley, park or any
 private property.
- 2) Definition of Loud, Disturbing or Unnecessary Noise. Sounds and noises shall be considered loud, disturbing or unnecessary if the sound or noise exceeds the levels set forth on Table 1, attached hereto and made a part of this ordinance.
- 3) Penalties. Any person who is convicted of violating any provision of this ordinance shall forfeit not less than fifty dollars (\$50.00) nor more than two hundred dollars (\$200.00) per violation. Any person who is convicted of a second or subsequent violation of the same provisions of this ordinance in less than 12 months shall forfeit not less than two hundred dollars (\$200.00) nor more than five hundred dollars (\$500.00).

Section 2. Effective Date. This ordinance shall take effect and be in force from and after its passage and publication as provided by law.

Section 3. Severability and Conflicts. If any section or part of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.

The above and forgoing Ordinance was duly adopted at a regular meeting of the Town Board of the Town of Winchester on $\sqrt{2022}$, by a vote of $\sqrt{3}$ ayes, $\sqrt{2}$ nays and $\sqrt{2}$ not voting.

NOISE LEVEL CRITERIA FOR CONSIDERING BARRIERS

Land Use Category	Leq(h) ¹ (dBA)	Description of Land Use Category
A	57 (Exterior)	Lands on which serenity and quiet are of extraordinary significance and serve an important public need and where the preservation of those quali- ties is essential if the area is to continue to serve its intended purpose.
