


Place carts at least 3 feet apart at the road by 6:00 a.m. on your pickup day. All collection services are Weekly.

Place the items listed below in your RECYCLING cart:

- Aluminum cans and bottles
- Tin cans, steel cans
- Glass bottles and jars
- Plastic bottles, jugs, jars, dairy containers, produce, deli, and bakery containers
- Newspaper, magazines, books, mail, school/office paper
- Envelopes, junk mail, and catalogs
- Flattened corrugated cardboard and paperboard (shoe boxes, etc.)
- Cereal boxes, milk, juice, and soup cartons
- Paper bags

Do **NOT** place recycling in plastic bags.

Place the items listed below in your TRASH cart:

- Shredded paper, tissue paper, paper cups, pet food bags
- Plastic bags, wraps, and films
- Styrofoam of any kind
- Motor Oil bottles
- Mirrors, window glass, ceramics or china, drinking glassware
- Construction materials
- Aluminum pans and foil, aerosol cans, paint cans, scrap metal, cookware, pet food cans
- Yard Waste
- Household hazardous waste

PROPERTY FRAUD occurs when someone records a fraudulent document in the county land records office. making it look like they own your home or property.




#### PROPERTY FRAUD ALERT
